"Knowing What To Do"

- The title of today's message can be understood in many ways
- "KNOW" is a word with many definitions ~ variations of meaning
 - 1. "to have information" / "I know the answer"
 - 2. "to have understanding" / "I know what you mean"
 - 3. "to be familiar with" / "I know Jim very well."
 - 4. "to feel certain" / "I know I returned that library book"
 - 5. "to recognize" / "I know a bargain when I see one"
- I'm using the word "know" in the 4th sense / "to feel certain"

Sermon Series ~ "What To Do"

- Today's message is the 1st of a 5-part series
- Originally intended for March Gary suggested "Marching Orders"
- The phrase "What To Do" is central to the series
 - 1. "Knowing What To Do" / Be reasonably certain of a goal or direction
 - 2. "Wanting What To Do" / Align our hearts with chosen goal or direction
 - 3. "Planning What To Do" / Direct our thoughts | actions towards goal
 - 4. "Choosing What To Do" / Avoid distractions ~ Stay focused
 - 5. "Do Do Do" / Hold ourselves accountable for progress $^{\sim}$ No excuses
- Head / Heart / Head / Heart / Hands
- Goal to transition from fretful "What To Do" to confident "Marching Orders"

- No doubt that Phil could (perhaps has) present on this topic thoroughly

- Today's message is "Knowing What To Do" / Being confident in the what
- Part of our confidence may come from other 4 definitions (review)
- But total confidence comes from somewhere else also
- That's what we want... But how do we get it?

Decision Making #1 – "Is it Ethically Allowed?"

- What we're talking about is the process by which we make decisions
- The Bible is filled with examples of good and bad decisions
- The first bad decision we find is that of Eve in the Garden
 - o **Read Gen 3.1-6** ~ "Now the serpent .. and he ate."
 - Eve's decision making process is clearly presented to us in v6
 - She never considered the ethics of the decision / "Am I allowed?"
- We can judge Eve harshly in this yet many Christians do the same thing
- III: Tony Bastine ~ Deacon's advice "God wants you to be happy"
- 1st Question: "Is it allowed?"

Decision Making #2 - "Is it Morally Right?"

- Another bad decision we see shortly afterwards involves Abram
 - o Read Gen 12.10-12 ~ "Now there was .. all that he had."
 - o God spoke to Abram in Haran then appeared to him in Shechem
 - Yet Abram chose deception to address his fears in Egypt
- Deception is <u>not always</u> morally <u>wrong</u> **Judges 4** tells of <u>Jael</u> killing <u>Sisera</u>
 - o Deborah and Barak sing a song celebrating Jael's act in Judges 5
- "What makes Abram's deception morally deficient?"
 - 1. Abram acted out of personal fear / Jael courageously overcame fear
 - 2. Abram acted out of self-interest / Jael acted out of civic duty
 - 3. Abram didn't appear to consult God at all his plan lacked faith
- 2nd Question: "Is it right?"

Decision Making #3 – "Is It Worth the Risk?"

- <u>Judah</u> in **Gen 38** gave no thought to risks / left his signet, cord and staff
 - He leaves off the search for <u>harlot</u> saying, "lest <u>we</u> be shamed" (v23)
- Jesus alludes to such decisions as common sense in Luke 14
 - o Read Lk 14.31-32 ~ "Or what king .. conditions of peace."
- 3rd Question: "Is it worth the risk?"

Decision Making #4 – "Am I (Are We) Prepared for This?"

- In the same discourse Jesus spoke of someone "intending to build a tower"
 - o Read Lk 14.28-30 ~ "For which of .. able to finish""
- The lesson is one of resources and preparedness
- 4th Question: "Am I prepared for this?" / "Is it beyond my abilities?"
 - <u>III</u>: Outlaw Josey Wales "A man's got to know his limitations."
- Recap the 4 questions thus far . . .

Xition: Our 5th question relates to time or timing . . .

Decision Making #5 - "By When Must a Decision be Made?"

- Some of us are prone to rush into decisions . . .
- Every married couple has to work this process out
 - Male <u>headship</u> doesn't mean wives don't participate in decision making
 - Husbands ought to include wives in the process
- Long ago Tabitha and I lived in the East Bay of California
 - We married in 1986 / We bought a condo, cat, and car in 1987
 - We had a daughter in 1988 / I took a job with NASA but wasn't happy
- **III**: Hawaii Vacation 1991 Fresh pineapple stands
 - o <u>III:</u> Big Ideas remote ball for cats / child security / nursery noise light
- Haste may reflect our passions & emotions more than our plans
- 5th Question: "By when must a decision be made?"

Decision Making #6 - "Am I Thinking Objectively?"

- All decision making is an opaque mixture of objective & subjective reasoning
 - Subjective refers to personal perspectives, feelings, or emotions
 - o Objective is the supposed elimination of all of that
 - <u>III</u>: Dragnet Objectivity is Joe Friday's phrase "Just the facts ma'am."
- We're trained to believe the best reasoning is objective / Probably true
- But we're tempted to make any subjective reasoning appear objective
 - Books & articles on marketing state that <u>all</u> buying decisions are subjective
 - o They insist pros and cons lists are just objective ruses to justify wants
- 6th Question: "Am I Being Honest With Myself (and Others)?"

Decision Making #7 – "Has God Led Me to This?"

- Belief in the sovereignty of God is something Presbyterians believe
 - o Even <u>liberal</u> Presbyterians I know advocate for election & predestination
- We know God uses us (everyone & everything) in His plans "His Story"
 - Rom 8.28 ~ "All things work together for good to those who love God, to those who are called according to His purpose."
- It's practically impossible for us to predict even small future events
- Yet we have access to details of our past "But do we mine that data?"
- Years ago Phil produced a diagram based on past experiences big arrow
 - He and Kathy shared that at the elder's retreat in January
 - On This analysis has given Phil much greater appreciation for God's plan
- 7th Question: "Has God led me to this?"

Xition: Let me share a current example of God's leading in my life . . .

Personal Example of God's Leading

- III: My UP Experience ~ Fall of 2017 (wanted greater responsibility)
 - o Each attempt to gain responsibility resulted in a loss of it
 - As I reflected on prior 16 months I thought that God wanted me out of UP
 - o I was shocked / I thought it was absurd to leave before full retirement
- But upon reflection I believed God wanted me out of UP
- Yet this also correlated with my personal wants / so I was suspicious

Decision Making #8 - "Is God With Me in This?"

- Through Christmas and early January I was wrestling with this issue
 - But I was reluctant to share it with Tabitha / Upsetting
- I'd already decided on this 5-part series by this time / emailed idea to Gary
- After Elder's Summit wanted to share with Tabitha but sought moment
- Met with AVP Jan 22nd / Met with Phil and Gary just afterwards
- Promised Phil I'd reconsider my motives in choosing to leave
- Next day (Jan 23rd) God reaffirmed decision
- Committed to sharing news with Tabitha Friday or Saturday
- Thursday afternoon (24th) received word that her father had passed away
- 8th Question: "Is God With Me in This?"

1 Cor 2 - Knowing God

- For months we've been reading / reviewing / discussing Knowing God book
- Read 1 Cor 2.9-12 ~ "But as it is .. given to us by God."
- I'd always thought of v9 as being a future event
 - Yet v10 and v12 clearly place it in the past and present
 - The word "know" appears 3 times in these 3 verses
 - o It appears twice more in the remaining 4 verses

Directed by God's Voice

- Read Isaiah 30.18,21 ~ "Therefore the Lord .. turn to the left."
- Is 28.23 ~ "Give ear and hear My voice, Listen and hear My speech."
- Is 30.30 ~ "The Lord will cause His glorious voice to be heard."

Psalm 119.105 ~ "Thy Word is a lamp unto my feet and a light unto my path." The light of the lamp extends only so far down the path . . .

Jude 24-25 ~ "Now to Him who is able to keep you from <u>stumbling</u>, and to present <u>you faultless</u> before the <u>presence</u> of His glory with <u>exceeding</u> joy; To God our Savior, Who alone is wise,

be glory and majesty, dominion and power, both now and forever. Amen."
